through on your planning. Use your plan. Don't put it in the bottom drawer of your desk and forget it. Your business plan can help you avoid going into a business venture that is doomed to failure. It is far cheaper not to begin an ill-fated business than to learn by experience what your business plan could have taught you at several hours of concentrated work. Finally, your business plan provides the information needed by others to evaluate your venture, especially if you need to seek outside financing. A thorough business automatically becomes a complete financing proposal which will meet the requirements of most lenders.
